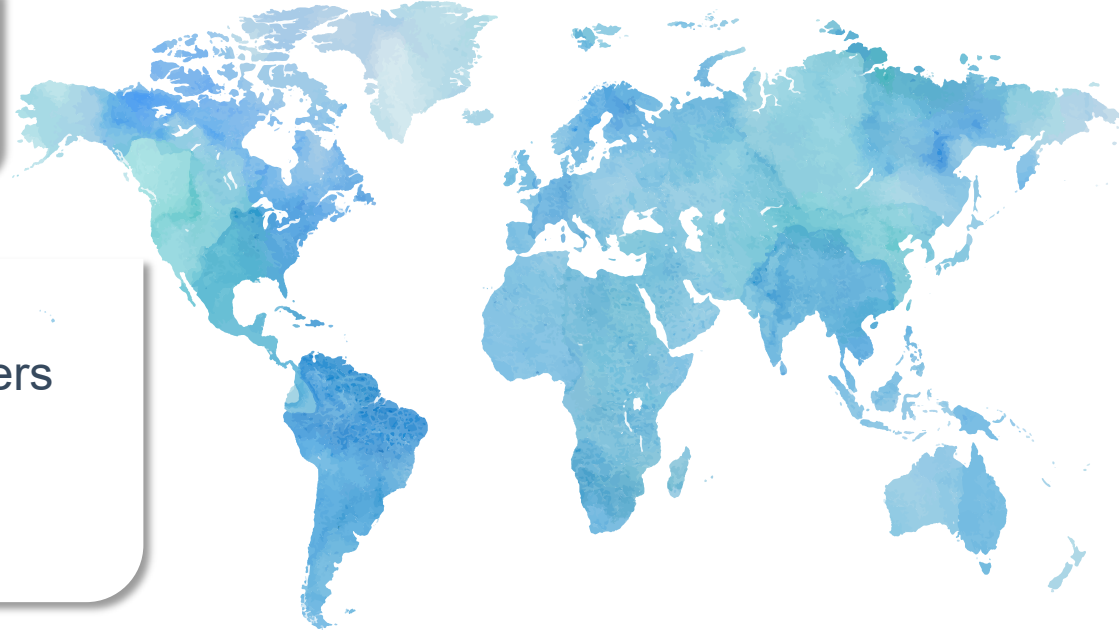

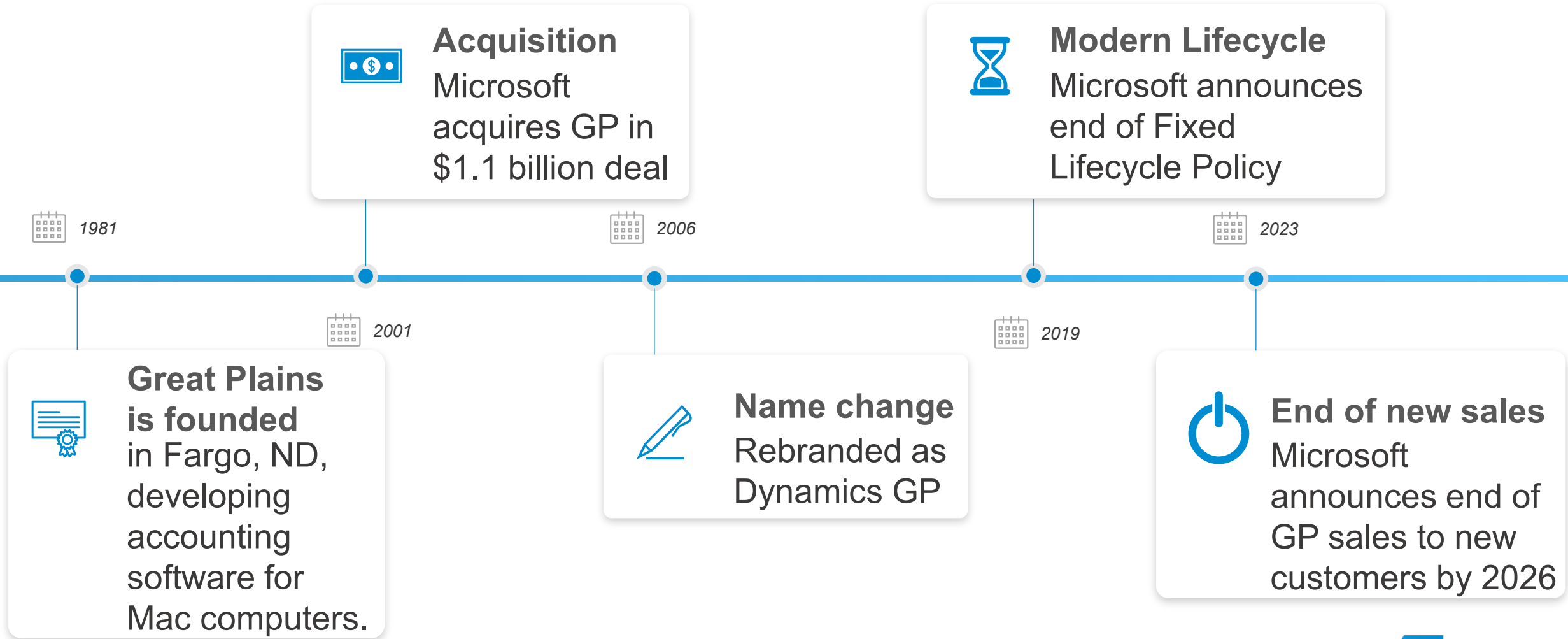

Things we love about GP

 - Direct database access gives you (nearly) infinite power

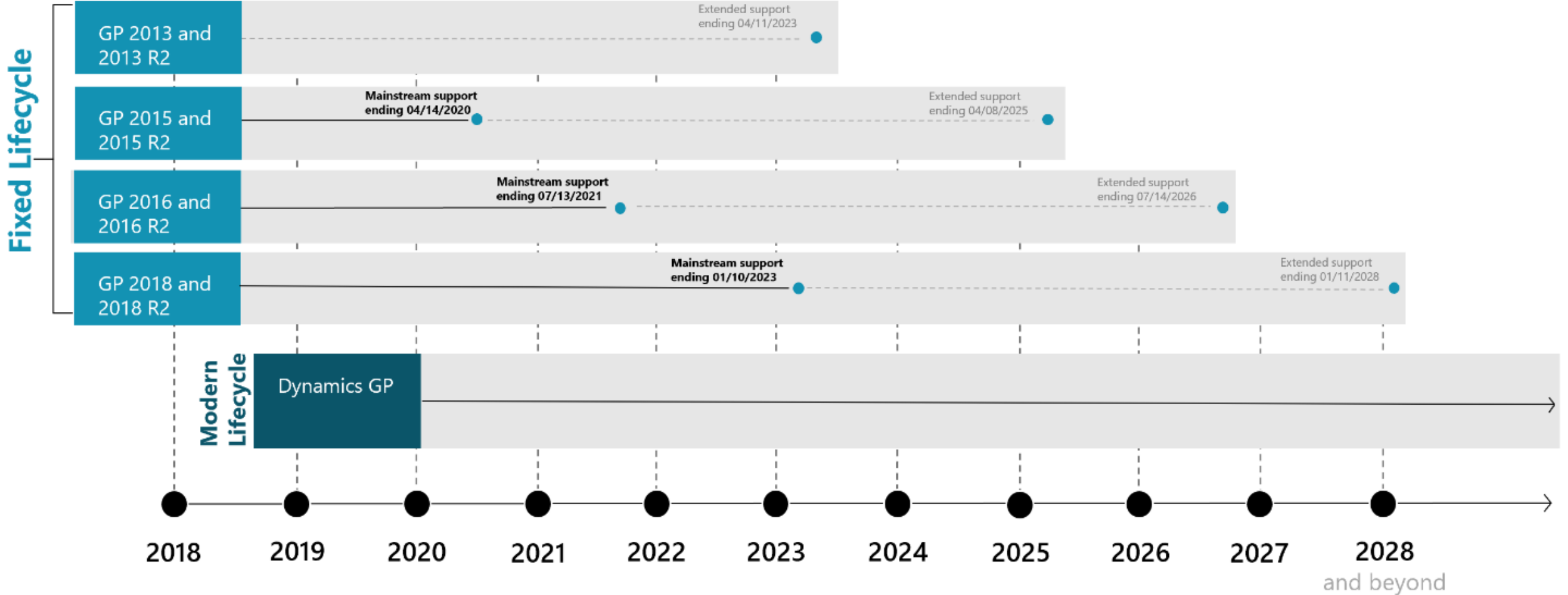


Trapped In Time

Is GP dust in the wind?

- Major feature updates are history
 - Version 18.6 (late 2023) was the last major feature update
- What is the “modern lifecycle” anyway?
 - Tax, compliance and security updates will continue through at least 2028
 - You have to stay up to date to remain in support
- Reading between the lines
 - Microsoft is shifting toward cloud services
 - Roadmap hasn’t changed since 2019

- Full control with on-prem

 - Direct database access gives you (nearly) infinite potential points of failure
